- 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. In case of the programs which have been granted provisional accreditation for three years, Yeshwantrao Chavan College of Engineering, Wanadongri, Hingna Road, Nagpur-441110, Maharashtra should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a revisit, as deemed appropriate by NBA Committees.

In case of the programs which have been granted provisional accreditation for two years, Yeshwantrao Chavan College of Engineering, Wanadongri, Hingna Road, Nagpur-441110, Maharashtra should submit the Compliance Report at least six months before the expiry of validity of provisional accreditation. It will require submission of pre-qualifiers before sending the Compliance Report for granting further accreditation.
