Note: The mandatory disclosure in prescribed format is required to be hosted on the website as per directions in the website failing which, action would be initiated as per the rules and regulations of the AICTE including No Admissibility and Withdrawal of approval.

The institution is required to submit two copies of the Compliance Report indicating the rectification of deficiencies, the mandatory disclosure and details of faculty recruited for each course in the prescribed format (available at AICTE Website www.aicteernet.in) to the concerned Regional Office latest by 31st August 2008 for consideration of approval beyond the period 2008-09. ***It may be noted that all the institutions are required to submit the Compliance Report alongwith requisite processing fee by 31st August every year irrespective of the period of approval.***

The Compliance Report must be accompanied with a processing fee of Rs. 10,000/- in the form of demand draft in the favour of Member Secretary, AICTE, payable at New Delhi. In the absence of processing fee the Compliance Report will not be entertained. Following the Compliance report, the Council would verify the status in respect of rectification of deficiencies through its random inspection without any prior notice.

The above approval if granted after rectification of deficiencies, would be subject to the fulfillment of the following conditions:

1. That the management shall provide adequate funds for development of land and for providing related infrastructure, instructional and other facilities as per norms and standards laid down by the Council from time to time and for the recurring expenditure.
2. (a) That the admission shall be made only after adequate infra-structure and facilities are provided in terms of norms and standards of the AICTE.
- (b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
- (c) That the curriculum of the course and the procedure for admission shall be as prescribed in the AICTE Regulations and the norms and standards of the AICTE.
- (d) That the admission shall be made by the institutions only and above the approval period, in special circumstances. In case any special admission is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution.
- (e) That the institutions shall not have any collaboration or tie-up with any other Government or University for conduct of technical course other than those approved by AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution.
- (f) That the institution shall not conduct any courses in the field of technical education in the same premises campus and/or in the name of the institution without prior permission approval of AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution.
- (g) The institution shall not conduct any non-technical courses in the same premises campus or in special circumstances. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution.
3. That the institution shall operate only from the approved location, and that the institution shall not open any off-campus study centers/extension centers directly or in collaboration with any other institution, under its organization for purpose of imparting technical education without obtaining prior approval from the AICTE.
4. That the tuition and other fees shall be charged as prescribed by the competent Authority within the limit as prescribed by the Council from time to time. No capitation fee shall be charged from the students and no student shall be given any concession in fee.

5. That the accounts of the Institution shall be audited annually by a certified Chartered Accountant and subject to inspection by the Council or any body or persons authorized by it.
6. That the Director/Principal and the teaching and other staff shall be selected according to procedures and experience prescribed by the Council from time to time and pay scales are as per the norms prescribed by the Council from time to time.
7. (a) That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and academic standards.
- (b) That the technical institution shall publish an information booklet before commencement of a year giving details regarding the institution and courses/programmes being conducted and infra-structural facilities including faculty etc. in the form of mandatory disclosure. The information may be made available to the stakeholders of the technical education on co-located basis. The mandatory information shall be put on the Institution Website. The information shall be revised every year. Information about all aspects of the institution.
- (c) That it shall be mandatory for the technical institution to maintain a Website providing the information. The Website information must be continuously updated as and when there is change in information.
- (d) That a compliance report in the prescribed format along with mandatory disclosure on the above conditions, shall be submitted each year by the Institution within the time limit prescribed by the Council from time to time i.e. 31st August 2008 for the current year.
- (e) That if Technical Institution fails to disclose the information or supplies false or incorrect information, appropriate action shall be initiated by the Council as directed by AICTE approved.
8. That the Institution shall display the AICTE logo prominently on the main entrance of the Institution and on the official website of the Institution.
9. That a Helpline shall be established with adequate number of helpline numbers, manned by trained staff, to receive AICTE queries.
10. That computer center with adequate number of terminals/Practicals etc. shall be established as per AICTE norms.
11. AICTE may carry out random inspections to monitor the compliance with the norms of the Institution and maintenance of norms and standards.
12. That the AICTE may also conduct inspections with or without notifying the dates to verify specific complaint representation, violation of norms and standards, mal-practice etc.
13. That the Institution by virtue of the approval given by Council shall not automatically become claimant to inform the Central or State Government.
14. *That in the event of a student/ candidate withdrawing before the starting of the course, the vacant seat should be given admission against the vacant seat. The entire fee collected from the student/ candidate after a deduction of the processing fee of not more than Rs. 1000/- (Rupees One thousand only) refunded and returned by the Institution / University to the student/ candidate withdrawing from the programme. It would not be permissible for Institutions and Universities to retain the School/ In-charge Leaving Certificates in original to force retention of admitted students (See Public Notice AICTE/03(01)/2008)*
15. *The Institute shall take appropriate measures for prevention of ragging in any form, in the directions of Supreme Court of India in Writ Petition No. 656/1998. In case of failure to prevent instances of ragging by the Institutions, the Council shall take appropriate action including withdrawal of approval.*
16. That the Management shall strictly follow further conditions to be specified by the Council from time to time.

17. In the event of non-compliance by the **NAGAR YUWAK SHIKSHAN SANSTHA, YASHWANTRA CHAVAN COLLEGE OF ENGINEERING, HINGNA ROAD, WANADONGRI , NAGPUR - 441 11** with regard to guidelines, norms and conditions prescribed from time to time the Council shall be free to take measures for withdrawal of its approval or recognition, without consideration of any related issues and that liabilities arising out of such withdrawal would solely be that of **NAGAR YUWAK SHIKSHAN SANSTHA, YASHWANTRA CHAVAN COLLEGE OF ENGINEERING, HINGNA ROAD, WANADONGRI NAGPUR - 441 110**


