Post force Majeure the payment shall resume as per agreement. In case the Force Majeure event continues for a period of 180 days, Parties shall have right to re-negotiate the performance schedule or terminate the Agreement.
10. **Waiver:** Any waiver by a party of any right or interest hereunder shall not imply the waiver of any other right or interest, or any subsequent waiver.
11. **Notices:** Any notices required by the terms of this Agreement may be given by sending them by facsimile transmission or by registered mail or by courier
