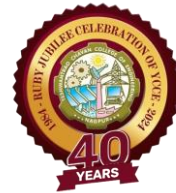

Q.1. Can I get the Govt. Scholarship?

Ans: - You are eligible for various scholarships, only if, your admission has been made through CAP. Students admitted under Institute Level quota cannot avail this benefit.

Q.2. Can I apply for all type of concession at a time?

Ans: - No. you can avail for only one kind of concession or scholarship at a time.

NOTE: All candidates read all the instructions carefully given below related to their scheme

Important Instruction

Aadhaar seeding to bank account is an important requirement for beneficiaries of various DBT schemes to receive DBT benefits in the student's account. It is hereby informed that students who are not able to receive their Post Matric Scholarship DBT due to issues in Aadhaar seeding can visit the nearest Post Office to open an India Post Payments Bank (IPPB) account with Aadhaar seeding. Following documents are required to open the account –

- Mobile number
- Aadhaar number
- PAN Card (if available)
- Scholarship application ID in case of DBT not being received due to Aadhaar seeding issues

This facility for opening of accounts in IPPB with Aadhaar seeding is available for receiving DBT benefits for other students and public as well. The account opening is done in real time and in a paperless manner.

Scheme : Post Matric Scholarship to OBC, SBC & VJNT Category Students (Scholarship)

Eligibility :

1. **Candidates should be admitted through Centralized Admission Process (CAP).**
2. Applicants should belong to OBC, VJNT & SBC category
3. **Applicants must be residents/domicile of Maharashtra.**
4. The annual income of the parents/guardians should be less than or equal to ₹2.50 lakh to be eligible for the Post Matric Scholarship. **Additionally, a valid Non-Creamy Layer certificate is required."**
5. **Only two children: - i) any number of girls applicants allowed. ii) boys' applicants maximum 2 children of the same parents will be eligible for the Scholarship.**
6. No scholarship will be granted to the applicant under this scheme from the date he/she accepts any other scholarship or stipend. Applicants must not be in receipt of any other scholarship/stipend concurrently
7. **75 % attendance is mandatory for the current academic year.**
8. The applicant shall remain eligible for the scholarship if he/she transfers from a Non-Professional course to a Professional course. However, if the applicant shifts from a Professional course to a Non-Professional course, he/she will be eligible for the scholarship.
