Subject:- System of applying Grade Cutoff marks

There are two systems for deciding Grade's cutoff marks as follows.

Statistical Method: Relative grading cut-off marks are calculated in every main ESE for regular students (group ≥ 30).

Absolute Method: Cut off marks table is already fixed for every grade (For D grade in Theory ≥ 40 , in practical ≥ 50).

- ESE Odd : (Main ESE)

Relative grading is calculated for regular students for group size ≥ 30 of Semester 1,3,5,7 during Odd ESE (Main exam). These cutoffs are also used for immediately following one Odd Re-sit.

During ESE Odd (Backlog) -Absolute grading is applied for any Ex-student of any Semester from 1 to 8

- ESE Even: (Main ESE)

Relative grading is calculated for regular students of group size ≥ 30 of Semester 2,4,6,8 during ESE Even (Main exam). These cutoffs are also used for immediately following one ESE Even Re-sit.

During ESE Even (Backlog) -Absolute grading is applied for Ex-students of Semester 1 to 8.

Notes:

- In each Main ESE relative cutoff marks are calculated for regular students as above.
- For any course if number of Regular students is ≥ 30 , absolute grading is applied.
- In absolute grading out of 100, minimum 40 marks are required in theory to pass.
- For Makeup exam only Absolute grading is applicable.

The grades awarded to the students will be converted into the equivalent grade points as follows

Table : Academic Performance, Grades, Equivalent Grade Points

Explanation:

'A+, A, B+, B, C+, C' Grade

A student who is awarded any of 'A+, A, B+, B, C+, C' grade in a course means the student has completed the course as per academic performance mentioned in above table.

'D' Grade

A student who is awarded "D" grade in a course means he has passed the course marginally

'F' Grade

A student who is awarded "F" grade in a course means the student must appear ESE again whenever it is offered next, until a passing grade (D to A+) is obtained. 'F' grades secured in any course stay permanently on the grade card of that examination. The weightage of 'F' grade is considered as zero in the calculation of the CGPA and the SGPA.

For the elective courses in which 'F' grade has been obtained, the student can reappear the same course directly in next ESE or "re-register to change of elective to any other course from the list of same Elective course along with practical if any."

'G' Grade

A student will be awarded "G" grade in audit course indicating successful completion of the course if the student satisfies the attendance requirements as stipulated. This grade would carry no grade points and will not be used in computation of SGPA or CGPA.

'H' Grade

A student will be awarded "H" grade in audit course indicating incompleteness of the course if he fails to satisfy the attendance requirements as stipulated. This grade would carry no grade points and will not be used in computation of SGPA or CGPA. Such student can re-appear for the same course or alternative course in any semester by contacting Dean (Academic Matters) office.

'I' Grade

A student having attendance lower than 75% in a course, whatsoever may be the reason, term is not granted, and is disallowed from appearing in the ESE for that course in that examination. In such cases the student will be awarded "I" grade.

The continuous assessment of that course (Theory or laboratory course) shall become null and void and the student will have to re-register for the course as and when it is offered.

Further, if any course is having continuous assessment=100 marks and the student fails to score minimum passing marks, then also 'I' grade is awarded.

'T' Grade

If a student has not completed the semester successfully and is absorbed into autonomy from RTM Nagpur University or lower SOE to higher SOE of autonomy, and if he has done the term work for the university course previously, which is equivalent to autonomous course, a student will be granted term of that course under autonomy and the student has to take the examination of equivalent autonomous course in the institution. In such cases 'T' grade is awarded in every failed equivalent course at the time of absorption.

The "T" grade will also be shown in the absorbed courses where the student has failed in the course and has opted to forego the continuous assessment marks. This grade will later be converted into suitable pass grade according to the performance of the student in the institutional examinations.

Absorption is subjected to the "Absorption Scheme" for that semester prepared by the respective Board of Studies.
