Notice - Revaluation (Grievance)

Last date for applying Revaluation.

Evaluation period:

Evaluation is completed normally within a week from the date of examination of that course.

Answer book showing to students:

Starts from 4th day & stops on 10th day from the date of the examination of that course.

Grievances:

Submit a Grievance form to the COE office on or before 10th day of the date of the examination for that course.

- A) Paid Grievance: In case of undervaluation, pay Rs 500/- in the account section & submit receipt to CoE with white Grievance form. (Refundable, if marks are changed ≥ ± 3. Must claim within a month)
- B) Free Grievance: In case of unvalued answer, wrong posting of marks or mistake in mark totaling, Grievance is accepted free with green form.

Responsibility of student:

Check your very own login. If any student does not find an evaluated answer book up to 7th day evening, they must contact respective HOD or FYC on 8th day.

If any student does not find an evaluated answer book in his login up to 9th day evening, they must contact CoE on 10th day before 2 PM.

Accepting Revaluation Form stops completely after Completion of practical examination and result processing starts.

Showing answer books is a facility. Students should not claim it as a matter of right.
