Training and Placement Policy 2025-26

(Applicable for all Final year students graduating in 2026)

- 1. After registering with the T&P Cell, if a student fails to attend any placement drive, they will not be allowed to participate in the immediate Mid Semester Examination and the next drive unless their parent visits the T&P Cell and meet in person with Dean or Director T&P.
- 2. After registering with T&P Cell, if a student is absent in two or more placement drives post end of teaching of 7th semester, they will be restricted from future placement opportunities offering a package above 5 LPA
- 3. If a student misses the company's pre-placement talk, he/she will be excluded from participating in that company's placement process.
- 4. If a student participates in the written test/GD but does not attend the interview, they will be debarred from participating in any future recruitment drives.
- 5. Any student who has a job offer in hand will not be allowed for any other placement drives except for dream status or core company (CTC > 8 LPA or decision lies with by T & P cell).
- 6. If a company withdraws its offer letter at any stage before the joining date, the TPCG cell or the college will not be held responsible. However, the college will assist in providing alternative opportunities.
- 7. After graduation, if the T&P cell offers an opportunity to unplaced students and they fail to attend, then they will be de-registered from future campus drives and must submit undertaking mentioning removal of their name from further placement drives.
- 8. Students must maintain professional conduct during placement drive. If found violated, he/she will be de-registered from further campus drives.
- 9. If a student is not registering for the company, then he or she will be debarred from placement process.
