Submit ‘Examination form’ Offline

Step 1 : Take the course completion certificate from the respective mentor allotted under SMS scheme.

Step 2 : Take signatures of the Mentor, SMS coordinator/HOD on Makeup exam form.

Step 3 : Take approval to appear in exam from Dean (AM).

Step 4 : Pay the exam fee offline in the account section.

Step 5 : Submit the offline exam form in the pre-exam section of CoE office along with ‘course completion certificate’, approval from DAM(AM) & exam fees paid receipt.

Makeup exam information:

1. In case of any issue in the offline exam form, **contact COE immediately on day 1.**
2. **ESE Odd-Makeup** is conducted after result of ESE Odd (main), along with Odd-Backlog all semesters & Odd Resit.
3. **ESE Even-Makeup** is conducted after result of ESE Even (main), along with Even-Backlog all semesters & Even Resit
4. If the student gates "F" grade in makeup exam then he can participate as an Ex-student in subsequent Backlog examinations.
5. If a detained student of previous session, registered for SMS scheme in current session for "remaining detained courses", then his/her Makeup exam will be conducted with timetable of Odd Backlog & Even Backlog only.
6. Do everything in time to help yourself/ your parents / your college & to avoid late fee.
7. Detained students should use "Makeup Exam" wisely.
8. The student who joined NEP batch after year down, should use "Makeup Exam" for MDM courses.
