- 2) (i) Working experience in Public Section undertaking is preferred. However, private section can also be considered provided the Industry has a successful continuous standing of at least 10 years.
- (ii) The experience can be considered only after production of certificate (experience) issued by the Competent Authority.
- (iii) The area of operation of Industry shall be related to the relevant field of discipline.
- (iv) The experience certificate shall include work profile, designation and duration of service.
- (v) 50% of the total service rendered in Industries shall be considered as an equivalent to teaching experience provided total experience is at least 10 years and above.
